Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2020-21 educational progress for Hunter Elementary School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2020-21 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

Hunter Elementary School has not been identified with any of these labels.

Continuous improvement in all subject areas at Hunter Elementary School is our focus. We focus on individualizing instruction to meet the learning needs of all of our learners. Our staff is committed to supporting all students. In order to meet the needs of all learners, Hunter Elementary School has a Child Study (MTSS) to provide intervention and support services for students who would benefit based on their current performance data. Additionally, we have two Intervention Specialists who support students in the areas of ELA and Math, and two Title I Aide who focus on Math intervention. Key focus areas for our building include reviewing our Tier I instructional practices in all areas and reviewing our scope/sequence and curriculum map in the areas of Reading, Writing and Mathematics. We have also implemented 1-1 technology in all grades. Additionally, we have a balanced approach to literacy instruction.

State law requires that we also report additional information.

1. Students in the Gibraltar School District are assigned to the school in their neighborhood, with bussing provided as needed. Opportunities for intra-district and inter-district School of Choice are also available.
2. The School Improvement plan for Hunter Elementary is a multi-year plan that focuses on improvement in all subject areas. Our most recent submitted plan goes through 2023. Our focus will be on best practices that apply to all subject areas. We use NWEA/MAP, M-STEP and local assessments to determine our focus for each subject area. We meet as a School Improvement Team multiple times during the school year to progress monitor and make necessary changes.
3. Hunter Elementary is a Kindergarten through Fifth grade building. Additionally we have two Young Fives classrooms, and two Early Childhood Program classrooms.

4. The curriculum at Hunter Elementary is aligned with the Michigan State Standards for literacy and math and Grade Level Content Standards for science and social studies. Our Director of Curriculum collaborates with principals and teacher leadership committees to continuously revise and improve our instructional materials and practices. 5. Student achievement results on M-Step testing can be found online at <http://www.mischooldata.org> In addition to this standardized online testing, students in K-5 are also tested annually using the Fountas and Pinnell Benchmark Assessment and Northwest Educational Association MAP Assessment.
6. Our highly qualified and experienced staff support all students while continuing their professional learning. We have a strong and involved parent organization, Hunter Family School Association as well as the Watch D.O.G.S program (Dads of Great Students.) Fall Parent-Teacher Conferences are well attended and we had above 95% for both 2020-2021 and 2021-22.

Hunter Elementary is committed to continuous improvement. At Hunter we take pride in our commitment to Positive Behavior Intervention, Targeted ELA instruction and interventions, Robust STEM Program, Peer to Peer Program and after-school opportunities for students.
