1. What multiple data sources were used to determine need?

We used our mentor logs, attendance logs through Edgenuity & Odysseyware, pass/fail rates in student enrollments, actual grades, campus attendance, content area analysis, student EDPs, school index breakdown, and state testing data to determine need.

2. Based on the data, what area(s) needs improvement?

As a school that was identified as ATS. We identified that student attendance, student growth, student proficiency, and assessment participation need improvement. From our local data, we identified that EDPs, career support, consistent communication, and course completion were areas needing improvement as well.

3. Write a measurable goal for each area of need.

Student not chronically absent will increase from 27% (2017-18) to 70% by 2019-20. Student Growth Met will increase from 25% combined (2017-18) to 35% by 2019-2020. Student Proficiency Met will increase from a 27% combined (2017-18) to 35% by 2019-20. Assessment Participation will increase from 80% (2017-18) to 90% by 2019-20. The amount of students with EDPs/Career support will increase from 75% (2017-18) to 85% (2019-20).

4. Describe the strategies and activities that will be used for each of the goals.

We plan to increase attendance and course completion by increasing communication with students and parents through Schoology, to create a graduation outline to show course completion and the amount of years it will take, have an Open House for Parents to show them how to keep track of their child's grade, implement action plans sooner, and to send progress reports on a regular basis. To increase student growth, student proficiency and assessment participation we plan to create more balanced schedules for students, increase credit requirements per grade level, and offer SAT prep workshops to better

prepare students for state testing. Finally, we plan to hire a counselor to help with EDPs, career planning, and course completion.

5. What future multiple data points will be used to determine if the goals are met?  
State testing scores, pass/fail rates, course completion, senior career paths, and EDP completion will be used to determine if goals are met.
6. What are the professional learning needs for staff and parents necessary to implement the strategies and activities?  
Staff will need Schoology and Xello training in order to improve communication with students/parents and to help support students with their career goals. Students and parents will need training opportunities in these programs also in order to understand and use them on a daily/weekly basis. Staff will also need continuous training on how to support apathetic students in order to keep them working on courses.
7. Describe how the plan and process will be monitored and evaluated.  
The plan and process will be monitored and evaluated by tracking the amount of classes students complete, survey parents as to how often they are checking Schoology, track student progress of students on action plans to see if there is an improvement, compare testing data from previous years, and use Xello and the counselor to track career paths of students with surveys. It will be evaluated to see if there is an increase in the completion of courses, see if there is less retention, an increase in student career planning, and if there is an increase in student assessment growth.
8. Provide the budget showing alignment to the plan.  
The budget would include hiring a counselor/interventionist to help students with their EDPs and course completion. The purchasing of Xello will help students complete EDPs and career plan. Planning career expos/field trips will also help students career plan and set career goals.
